# The USDF Annual Convention: Fellowship and Controversy -By Allison McKenzie

The annual United States Dressage Convention was held among the beautiful mountains of Salt Lake City, Utah from November 28 to

December 1, 2018. I was proud to be the voting delegate on behalf of our organization and excited to bring home updates and news from our governing body. While one portion of the event was personal for me due to the fact that I am beginning the journey of being accepted into the USDF Technical Delegate program, a majority of the convention revolved around educational symposiums with some of the country's finest judges as well as the opportunity to vote on our memberships' behalf at the Board of Governor's meeting. While there was no shortage of talk about the new Safe Sport program, a majority of the conversations revolved around the new freestyle score rule. This year the USDF/USEF passed what is referred to as an "extraordinary rule change" raising the qualifying score to ride in a musical freestyle from 60% to 63%. In researching this measure, I was able to glean that the USDF Executive Board had approached the United States Equestrian Federation (USEF) board to have the new rule passed immediately. In order to achieve expediency, the USDF labeled the new measure an "extraordinary rule." It was not made clear why the USDF took this measure, though there was some speculation that it had to do with the new tests being published beginning in 2018/2019. While many delegates were upset with the increase in score, even more were upset with the way it had been done i.e. the "extraordinary rule." There were many who took to the microphones to express their dismay directly to the USDF board. Some felt that the score change would make it harder for the grassroots Dressage rider to participate in musical freestyles – an aspect of Dressage that they enjoy and feel is an attainable goal for them. Others were upset that the USDF made this move without the knowledge of the general membership.

Conversely, many judges I spoke with were very much in favor of the rule change. Sue Hughes, a Michigan-based judge said "We're better now so we need to keep raising the bar." This followed a passionate speech from Debbie McDonald, the new Technical Director of the United States Dressage Team, outlining the strides US Dressage has made on the international scene, becoming a force to be reckoned with and standing alongside Germany, Great Britain, and the Netherlands on international podiums. Margaret Freeman, a member of the USDF board and judge also echoed that sentiment by saying that the increased score keeps us competitive with the rest of the world.

When it came time to vote, the membership decided to direct the USDF Executive Board to ask the USEF to rescind the rule change. However, in the interim the rule change still stands until a decision is made by the USEF. The USEF could decide to not rescind it and it would become permanent. In any case those who plan to compete in musical freestyles need to be aware that the minimum qualifying score

to ride in a musical freestyle is 63% to be obtained in the highest test of the level of the freestyle. Any changes or updates to this rule will be published on the USDF website as will any information pertaining to it.

Another topic that was voted on was a proposed increase in membership dues for the Group Members Organizations. This issue ended up being far less contentious than I originally thought it might. In both the Regional meetings and the Board of Governor's (BOG) meetings it was made clear that without the dues increase funding for many educational programs would have to be cut, including the USDF Schooling Show Awards program, which is still somewhat in its infancy. Additionally, the cost of health insurance for the 33 employees in the USDF office has increased. The measure to increase the dues for GMO's was passed overwhelmingly. The dues increase however will not take effect until December 1, 2019.

In addition to the topics up for vote at the BOG meetings, there were plenty of educational/informational forums presented. In these I learned that the USDF is working to maintain a large presence on social media i.e. Facebook, Twitter, and Instagram. Despite this however there are still many members that don't visit the USDF website or social media platforms to learn about educational opportunities available to them. As a compliment to the USDF connection, which will soon only be published bi-monthly, the USDF will be launching YourDressage.org.

Additionally, the USDF has been keen on emailing surveys to the membership to find out more about their use of technology and how they prefer to receive information so that the organization can more appropriately steer opportunities to them. A majority of members however, do not return these surveys.

Among the topics discussed in the USEF/USDF Open Forum were new rules that addressed mandatory reporting in the event of a horse collapsing, education requirements for show managers, minimum age requirements for horses at Fourth Level, as well as the fact that the Rider's Tests have now been removed. In the GMO Roundtable discussions, the issue of the Safe Sport Training was examined and the general feeling that its effects will trickle down to GMO's was discussed. This would mean that how insurance companies would view a GMO would depend upon whether or not the GMO's board had completed the Safe Sport Training. The Safe Sport Initiative was signed into law by the President of the United States and the USEF has made it mandatory for all organizations under its "umbrella" i.e. the USDF, the United States Eventing Association, and the United States Hunter Jumper Association, among others. Anyone who renews their membership with the USEF will have to complete the Safe Sport Training Modules.

Lastly, elections were held for the USDF Board. We bid farewell to George Williams who ended his term as President and Vice-President Lisa Gorretta was elected as our new President. Many of us in Region 2 are quite familiar with Lisa, who has been a Technical Delegate and FEI Steward for many years and hails from Chagrin Falls, Ohio. Charlotte Musselman will be the new USDF Treasurer and on a more local note, Debby Savage will be taking over for Ken Levy as the new Region 2 Director.

It was a pleasure and an honor to represent the Midwest Dressage Association at the USDF convention. It was incredibly educational and a fantastic opportunity to meet with, and talk to many other competitors, judges and Dressage enthusiasts from all over the country. I am proud to have represented the MDA to the best of my ability and look forward to bringing the information that I learned to future board meetings.
