And another group of people who you know but often do not group with those listed above? Barn owners. For those of you who board your horses, you no doubt are frustrated that you don't have access to them because of the mandatory shut down. You are

angry, worried, and need comfort. But for those who are entrusted with your horses' care, it is equally frustrating and frightening. Not only are barn owners and trainers losing income in all of this, but they are still having to go out to stores to buy feed. They are still working as hard as they ever did – but now with a drastically reduced income. They are still caring for their equine charges – and trying to comfort owners at the same time. The battles that barn owners and trainers are currently fighting are not being seen. They're not making the news. No one is writing stories about them. But they're there doing their jobs in a situation that they never expected to be in. So while we are out there struggling to find common ground – to support and encourage – think of our trainers, barn owners, and others in the equine industry. They work in the shadows and are struggling to find light in all of this.

Rescheduling Our Lives...

A List of Revised Schooling Show Dates and Other MDA Events

Due to the complications that Covid-19 has brought to our country, many shows and educational events have had to be cancelled or rescheduled. The Midwest Dressage Association follows the guidelines put forth by the United States Equestrian Federation and the United States Dressage Federation. Therefore there will be no points awarded for shows that take place before or on May 31. This includes the USDF Schooling Show program. As the Covid-19 situation is continually evolving, the MDA will strive to keep everyone updated on any changes through our website and Facebook page. As of this writing, all schooling shows scheduled in April and almost all of May have been cancelled. Events and shows also affected are as follows:

-The MDA Bootcamp that was scheduled for May has been rescheduled for October 2-4, 2020. Those interested can use the same registration form.

-The clinic scheduled with Bill McMullin for the end of May has been cancelled.

-The Instructor Certification Program workshop scheduled for the end of May has been rescheduled for the fall.

-The June schooling shows at Rattlewood Farm have been cancelled.

-The May 9/10 schooling show at Wyn Farm has been cancelled.

Temporary Rule Changes to Year-End Qualifications

The MDA Board of Directors has decided that since the ongoing pandemic has shortened our show season, we will adjust the requirements for year-end awards. For 2020 only in order to qualify for year-end awards riders must have two scores, ridden in two different shows, and received those scores from two different judges. One of those scores must be from the highest test of that level (Test 3.) This applies to both schooling shows and recognized shows. Scores obtained from recognized competitions held between October 1 and March 16 still count.

Previously the qualifications were three different shows, three scores, from three different judges. Please note that this change is for this season only.

US Equestrian Announces First Webinar in Series...

Webinar 1: Planning for a Safe Return to Competition

Monday, May 4, 2020 at 3:00pm EST

Lean how USEF is planning to facilitate a safe return to competition following the COVID-19 suspension. This is a good opportunity for trainers, exhibitors and competition managers to understand how to work together to create the safest possible environment for everyone as we look ahead to restarting 2020 competitions early as June 1 with a phased regional approach in line with local and state government restrictions. USEF Guidelines for Competitions will be shared. These guidelines have been developed by Dr. Mark Hart, USEF's Team Physician and Chair of the FEI Medical Committee, with input from competition management. Panelists will include USEF CEO Bill Moroney, Dr. Mark Hart, USEF General Counsel Sonja Keating, ESP President Michael Stone, and trainer John Madden.

This webinar event will be open to USEF members with 1000 spots available on a firstcome, first-serve basis. Registration will open April 30. The virtual webinar will be held via Zoom. We encourage participants to submit questions in advance when registering. There will be a Q&A session afterwards. The recorded event will be posted on the USEF Network at the conclusion of the session.

In 2018, Eleanor and her horse, Galassia, were MDA's year-end champions in the open division for Training and First Levels. In 2019, they were the 2nd Level champions. Additionally, Eleanor was honored with MDA's 2019 Jean Brown Memorial Award in recognition of her strong work ethic, sportsmanship, and volunteer work.

Eleanor shared, "I am so grateful to be receiving the Karen Skvarla Fund grant and continuing my riding education with Lauren Sprieser throughout 2020. This opportunity wouldn't have been possible without the support of The Dressage Foundation. With this grant, I look forward to improving myself and using what I learn in my training to help other horses and riders."

The purpose of the Karen Skvarla Fund is to provide grants enabling dressage professionals to pursue training or educational opportunities. Grant applicants should be in the beginning stages of their dressage careers as instructors and/or trainers. The Karen Skvarla Fund Grant selection committee will especially look for applicants who are eager to grow and improve, and who are fair and respectful to both students and horses.

TDF Awards Carolyn Van Cise Fund Grant to Nina Neumann



The Dressage Foundation is pleased to announce that the 2020 Carolyn Van Cise Memorial Sportsmanship Fund Grant has been awarded to Nina Neumann of West Bloomfield, Michigan.

Nina has been riding since she was a young child and is a member of the Midwest Dressage Association. Nina currently trains with Liz Snoblen at Equinox Farm in Highland, Michigan, and competes at local schooling shows with her rescue horse, Mouse. Her goal for 2020 is to continue building a relationship with Mouse and move up to First Level. Nina is also pursuing a B.S. in Biology with a minor in Psychology at Wayne State University. She works as a student researcher in a cancer research laboratory at Karmanos Cancer Institute in Detroit.

Nina intends to use the \$500 grant to ride in a clinic with John Lassetter later this year.

She shared, "I am beyond thankful to The Dressage Foundation for awarding me the Carolyn Van Cise Fund grant! It will allow me to participate in a clinic taught by FEI dressage rider, John Lassetter, and offer me insights into my riding that are beyond any level of training I have ever received. I am more than excited about this opportunity since it will allow me to fulfill a long-time training goal of riding in a clinic with my heart horse, Mouse. I adopted Green Mouse 6 years ago, fresh off the racetrack as a 4-year-old. After giving him the time he needed to be physically and mentally ready, we started competing together last year. This horse has so much potential and determination in him! I am thankful to Carolyn Van Cise's family and friends for their generous donations to support this grant, which will allow me to further my training and let my horse shine!"

Carolyn Van Cise was active in Michigan's dressage community for many years as a trainer, instructor, judge, and mentor. Dressage was her passion and she served as a role model for those she knew. The Carolyn Van Cise Memorial Sportsmanship Grant is awarded annually to a rider under age 25 who is a current Michigan resident and best exemplifies the qualities that Carolyn found most important in life, including the characteristics that demonstrate positive sportsmanship principles.

Recipients of this grant will receive \$500 to be used towards expenses associated with attending a specific educational Combined Training event or dressage event of their choice.
